The Controller of Communication Accounts, J&K Telecom Circle, Jammu propose to engage retired Group ' B' Gazetted and above, officers from Department of Telecommunication/Posts, other organized Account services of Government, (BSNL), as consultants on contract basis in this office on the following conditions. The applicant should apply for the said post on the proforma attached.

**Tenure of Short-Term Contract**

The retired person shall be appointed on short term contract basis for a period of three (06) months based on his/her performance and requirement of his/her services the contract can be further extended up to a maximum six terms of six monthly or 65 years of age whichever is earlier.

**Age Limit**

Candidate should not be more than 65 years of age as on 01-01-2018.

**Computer Literacy**

Computer literacy and knowledge of Accounts is desirable.

**Remuneration for hired retired personnel**


The consolidated fee/remuneration payable to retired persons engaged on short term contract basis shall be restricted to the difference between last pay drawn (as per 6<sup>th</sup> CPC) by the retired official and basic pension +DA at the rate applicable for Central Government Employee from time to time. The person so engaged will not be eligible for other allowances and benefits. The payment will be made on monthly basis.

**Termination of Contract**

The engagement of retired personal on short-term contract basis can be terminated by either of the party with prior notice of 30 days.


